the Jim Crow era to intimidate those of color. She urged the Board to think about the relation to the law that was just repealed.

The Board Members then individually commended the Elections Staff for performing their duties in an exemplary manner while ensuring safe, legal and secure elections.

6. Election Supervisor Update

Elections Supervisor Shannon Nettles presented her report to the Board:

- New code books will be available in September with updates from the passage of SB 202
- Budget meeting with County Finance staff and Board of Commissioners was very successful
- Certificates for Poll Workers have been delivered and Framed Certificates for Polling Places are currently being delivered.
- Georgia Voter Registration Conference has opened registration with no restrictions on limiting how many staff and Board Members can attend. The conference will be held on Jekyll Island August 29 September 1, 2021.
- SB 202 allows for the Absentee Ballot application portal to still be active, but applications will need to be uploaded to the site with a real pen and ink signature of the voter. New Ballot Box requirements are being reviewed.
- The 2021/2022 Voter's Guide is nearly complete and Board Members have a copy in front of them. Please provide your feedback.
