## **Camden County Recognizes Art Contest Winners from Camden County High School**

**WOODBINE, GEORGIA – April 23, 2015** – In celebration of April's National County Government Month, Camden County High School (CCHS) Art Students were invited to participate in the Board of Commissioners local Art Contest. In keeping with this year's theme, ***Counties Moving America Forward: The Keys are Transportation and Infrastructure***, students were asked to come up with a creative design using any medium of their choice. Traditional scene, modern design, and collages were all welcome and could include Pastels, Acrylic Paint, Ink, Chalk, Watercolor, Markers, Charcoal, Oil Paint, Pencil, and Pen.

Students of CCHS Art Teacher Grayson Day submitted over 40 pieces of artwork. All entries were judged on Clarity of Theme, Creativity and Originality. Mr. Day has been teaching art for 15 years and enjoys giving his students the opportunity to be involved in community events. Projects like this allow them the chance to gain a great deal of information and insight into our local government."
