

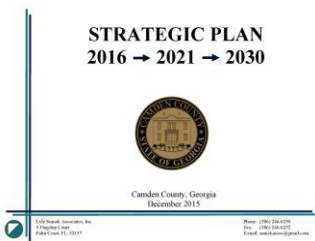

Commissioners set 2016 Action Agenda



WOODBINE, GEORGIA – February 9, 2016 – Tonight during their regularly scheduled meeting, the Board of County Commissioners (BOCC) unanimously adopted a new Action Agenda for the County’s Strategic Plan. The Strategic Framework for the future of Camden County is well documented in the *Vision 2030, Goals for 2021* and the new *2016 Action Agenda*. The entire Strategic Plan looks at five-year outcome-based goals, all with measurable objectives, and specific issues and projects that need to be addressed by the County.

Introduced in March 2015, the County’s Strategic Plan has been a successful work in progress over the last year. Beginning in 2014 with the public’s input regarding the future of Camden County, including a Citizen’s Summit, citizen surveys and background interview sessions with members of the community, important strategic planning sessions were also held with the County’s Management Team and the Board of County Commissioners. In December 2015, Commissioner’s and Management met to review the many accomplishments of 2015 and refocus on an action agenda and direction for 2016.

County Administrator Steve Howard said this process was a huge undertaking. “I applaud everyone for their efforts to make Camden’s new strategic plan a success. Hard work and dedication to our Action Agenda items ideally lay the framework necessary for a bright future and a successful County Government. This detailed roadmap for Camden’s future is vital. The Strategic Plan is a living document. It is critically important to continually review, edit and update the Plan to ensure progress towards meeting the strategic aims and objectives are realized.”
